Discussion on available Bond funds. Question on why the taxes line item was over the budgeted amount. [Post meeting answer - Budget for taxes was *estimated* in August 2022, and payment is in January 2023]. Utilities - Propane expenses have been higher than expected. It was noted that we are in the first year of operation with the new utilities set up. Electricity is trending lower than previous years, but there is concern over the Propane use. A possible issue is the Bays at station 31.

Chief's / Training Report See attached.

The Tunnel 5 fire was reviewed in a After Action Review with the local fire Departments (KCFD3 WSFD and Bingen FD). The response to the fire from local agencies was instrumental in keeping it from spreading further than it did. Several houses were lost.

The structure Fire in BZ corner was a loss. KCFD3 was on scene within 8 minutes of dispatch. It was a newer construction Mobile home. There were only 8 firefighters that could safely go into the building that day. The fire spread through the roof. Many valuable items were salvaged by the firefighters before the building was a total loss.

The training report will be completed later due to the transitioning of laptops and wildland fire activity.
