AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Klickitat County Fire Protection District No. 3 from January 1, 2017 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement – public works, purchases, and professional services
- Compliance with public works – prevailing wages, change orders, and retainage requirements
- Accounts payable – general disbursements and credit cards
- Payroll – gross wages
- Use of restricted funds – bond proceeds

INFORMATION ABOUT THE DISTRICT

Klickitat County Fire District No. 3 was created on November 4, 1952 and serves the incorporated communities of Husum, BZ Corners, Snowden and urban growth area of White Salmon. The District operates three fire stations to serve approximately 5,000 residents in a 50 square-mile area. Services provided include basic emergency medical care and fire protection.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as one full-time employee, two part-time employees and 30 volunteer firefighters. The District received annual operating revenues of about \$471,000, \$494,000 and \$867,000 during 2017, 2018 and 2019, respectively.
