# Approval of Minutes:

3. **Budget**: 2016 line items over budget include; vehicles, rescue apparatus and professional services. All are explainable.

Eric Bosler asked about the expenditure in professional services. The overage was due to contracting Bob Merritt for the hiring process, and additional legal counsel fees for the ambulance. We also pay for payroll services.

4. Investment of funds

Maintaining \$100,000.

**Correspondence:** PUD costs have increased. Stations 31 and 32 are on budget accounts, and have seen a significant monthly increase. Enduris insurance will also be increasing.

1. Current priority projects include: budget for 2017, and the 'half start' list.

# Chief's Report - Chief Wes Long

**Safety**: Two accidents have been reported but doctors were not seen in either case. A Safety Meeting has been requested.

#### **Customer service:**

- Chief has received a couple of emails noting the good work KCFD3 responders do in the field.
- Chief met with Skyline Hospital CEO to talk about KCFD3s role with EMS in the future. AMR and HMS submitted proposals for the recent R.F.P. There is interest in reviewing the role fire districts play in the EMS system. The task force for KCFD3 emphasized EMS is a priority which is why the commissioners opted to enter into debt for the new ambulance. Most notably, there is dialogue and options for reducing waiting times for customers in emergencies.

# Projects:

- Chief is still in the process of meeting community groups and will be at the next Husum Community council.
- The half start list will be reviewed and prioritized in the next month. Chief invited the commissioners for input.
- 2017 budget planning will begin next week.
- Fire Prevention Officer Eric Bosler has been very busy. He and the Chief have visited customers and developers to discuss access to sites.

# Fire District and Firefighter Association Events:

- The KCFD3 Volunteer Firefighters Association has elected Charles Virts to be their representative for the Board for Volunteer Firefighters which covers the Volunteers L&I and pension funds. The Association has also had to elect a new secretary.
- Fire Fighter of the Year Ron Reynolds was presented with firefighter of the year by Chief Virts. This was presented at the volunteer firefighters association meeting as Ron was absent from the appreciation dinner in January.
- New Vehicle 'Roll-in" ceremony for brush 322 and Medic 316 I scheduled for August 2.

# Community events:

- White Salmon River Fest was at station 31 on July 13.
- One small fire resulted from July 4<sup>th</sup> activities. KCFD3 and White Salmon were both fairly quiet during the holiday.
- Social Media Chief has been updating the district's Face book page.

# Fleet:

- B322 is in service, but requires a service.
- Medic 316 is in service Thank you to Captain Renault for the work put into transferring all the
  equipment. Decals will be applied July 15, and Captain Renault is working hard at doing that project 'right'
  but controlling the cost.
- Ford Expedition will need oil change soon. This vehicle needs to be addressed in the next budget cycle (153,216 miles)
- Reviewed Maintenance records of fleet. Recommendation is to increase efforts in this area.
- Engine 321 –no other issues with the pump control.
- Tender 314 experienced damage to the drop chain system while out on a hire for DNR. Chief does not
  intend to replace the dropdown chains as they do not work in deep snow. On a lighter note the service
  the tender provided generated \$2800 for the department.

#### Facilities:

- Station 32 it looking great, thanks to the firefighters for cleaning it out. Chief was also approached by a community member expressing an interest in helping to clean the kitchen and meeting room.
- Station 31 overhead door was repaired. The doors do not need to be replaced they just need routine
  maintenance and this will be factored into the budget next year,
- Stn 33 light is bad, and will be repaired.

# **Personnel Activities and Achievements:**

Employee review- District Secretary

### Training Report: Assistant Chief Nelson.

- AC Nelson attended the BNSF oil by rail training in Colorado. Played a short video for the commissioners.
   This was one of the best trainings he has attended. Several firefighters from White Salmon and Bingen have also attended.
- There is a foam trailer stationed in Bingen for rail events and will be used in training so departments are familiar with its capabilities.
- Chief Long covered training when AC Nelson was away and covered ventilation.
- School Bus we have acquired a school bus for training purposes.
- Training is reflecting the skills required in the field. SCBA confidence is improving with drills. Last training session Captain Renault set up search and rescue drills.

# **EMS division:**

Captain Renault updated the commissioners on the County wide OTEP training being scheduled for the future. Grant funds pay for the online OTEP training. There are also grant opportunities to cover the cost of hosting new classes and the county is looking to put on more classes including advanced EMT classes. Captain Renault noted that the classes would only be for those who show commitment. We currently have 10 EMTs and 2 paramedics. Chief Long also commented that advanced training improves quality of care for the customers, as training builds confidence.

# Ongoing Business:

- <u>2016 Ambulance</u>: Captain Renault collected the ambulance, he did the walk round and all was in order on collection. It is set up for the graphics to be applied. The UHF radio is installed to enable easier communication with Skamania EMS. Equipment has been switched over.
- <u>Surplus vehicles</u>: Resolution was presented to surplus the ambulance and the procedure for closed bid sale of the vehicles. *Motion to approve resolution 2016-16 to surplus the 1999 ambulance made by commissioner Connor, seconded by commissioner Montag, (3 yay 0 nay)*
- Sealed bids for the two surplus vehicles will be opened at the next commissioner meeting.
- Annexation petition A parcel on Nestor Peak was previously scheduled for a hearing in May and the
  notices posted in the area created interest from neighbors to annex in to the district. The hearing was
  postponed but there was hope we would have more properties involved. Several e-mails were sent but
  we have not heard any more from the neighbors. We will therefore plan the next hearing for August 11.
- <u>Payroll administration update</u>: The following items have been left on the agenda until staff can move forward with them.
- a) Direct deposits
- b) Deferred Compensation
- c) Disability compensation

Active 911 user agreement: This document gives the terms for the agreement. It is a contractual
agreement between Kcfd3 and Klickitat County Emergency Management. Motion to approve agreement
made by Commissioner Montag, seconded by Commissioner Connor. (3 yay, 0 nay). Agreement signed.

- Active 911 Policy 4.12: This document sets out the district's responsibility to provide access for the
  volunteers and limits the cost liability. Motion to approve policy 4.12, made by Commissioner Connor,
  seconded by Commissioner Montag, (3 yay 0 nay).
- Hazard mitigation plan for Klickitat County: This plan is still in progress.

## **New business**

- 2017 budget: In addition to the normal process, Chief requested information from commissioners on preliminary non capital projects the district should work towards. Fixed expenses and priorities will be established. The budget submission date is November 30. Looking at the calendar we will try to have the hearing in September, and approval of budget in October. If the commissioners intend to go to the voters for a levy, they will have to factor the cost of the ballot included in the budget. Chief has spoken to Jim Nelson who is a contractor that can help with the preparation and process (another expense the budget should account for).
- <u>SCEMS radio user agreement</u>. We have installed a UHF radio in the ambulance and this user agreement
  needs to be sent to chief Hildebrandt in Skamania County Fire med frequency review board. Motion to
  approve agreement made by Commissioner Connor, seconded by Commissioner Montag (3 yay, 0 nay).
- Good of the order: from Eric Bosler the written reports from the chief and assistant chief are a great idea, he suggested a copy be available for the public to read too.

- Received two separate emails from outside fire personnel praising our response and quality of work for the last two mutual aid brush fires in Wasco County.
- I will be reaching out to neighboring agencies (all) and community members in conjunction with learning KCFD operations and administration activities. As expected, this will take time.
- Meeting with Skyline Hospital CEO KCFD3 Ambulance participation. 7/14/16

# Projects:

- Actively meeting personnel and community leaders: <90 days</li>

# Fleet:

- Brush 322 needs annual servicing (oil, air, fuel filters, oil, brake inspections, steering suspension inspections etc.) I cannot get it in to the bus garage until after August. Will pick up supplies and perform this function in-house.
- Medic 316 is in service. Going in for decals on 7/15. Captain Renault is working hard at doing that project 'right' but controlling the cost. He and I have discussed the importance of sticking to our allotted funds.
- Ford Expedition will need oil change soon. Note: While I am NOT interested in spending any money, this vehicle needs addressed in the coming budget cycle. 153,216 miles as of today.
- Reviewed maintenance records for the fleet. I will recommend, in the 2017 budget proposal that the fire district increase our efforts in this area.
- No known additional problems with Engine 321's pump control.
- Tender 314 experienced damage to the drop chain system while out on hire for DNR.
   They have been removed. As this is a tender, I am not convinced I'll replace them.
   Rather, we will ensure good tire chains are available. No final decision as of yet.

# Facilities:

- Station #2 (Cherry Lane) received a HUGE cleaning by Captain Helton and FF Griffiths on June 13. The truck bay has been organized with a long term plan to get rid of junk.
- Station 2 I found someone willing to stop in about once a month for 15 minutes and help keep the meeting room clean. Will be getting rid of old furniture soon.
- The apron has been cleaned. Public works used their road sweeper to clean the blacktop of rocks.
- Still needs yard work completed.
- Station 1 Watering the yards to keep them fairly moist. The backyard is now cleaned up.
- Station 1 Overhead door is in on 6/14 to repair door #'s 1, 2 and 3. I am getting price
  quotes to have services completed on all 11 KCFD doors to prevent accidents and
  breakdowns. (2017 budget planning).
- Station 3 need to replace the man door exterior light. It's on 24 hours a day. Need to install a day/night light.
- Station 3 Weeded the exterior.
- Station 3 Seeking a plan to repair the water trailer and pain it. FEPP property.

# **Training Report**

Training taken place from June 14th. thru July 14th. 2016

- 1. Tender operations, supplying an engine with water.
- 2. Foam applied onto a fuel tanker for cooling application
- 3. Chief Nelson went to Pueblo Col. for a 3 day training by "Crude by Rail" sponsored by BNSF.
  - a. All expenses paid, air fare, rental car, room, and a credit card for fuel and food. It was some of the best training I have ever received. My goal is to send as many of our volunteers to the class as possible. I have a whole new respect for the rail industry and the ability of the new rail cars from sustaining damage on impacts. We now have three Crude by Rail trainees in the district. I have four names to send next.
- 4. Following up with Tactics and Strategy class that was held 6 months ago or so, we introduced another video on the importance and danger of cross ventilation inside a fire building. ie, Firefighter have been killed when a hallway becomes total involved with fire in just seconds from the intense heat caused by total involvement of the gases of combustion.
- 5. We now have a school bus we can use for drill. It was donated by White Salmon School district for us to use throughout the community. On July 30 OTEP is putting on a MCI drill involving a school bus and a motor vehicle crash.

The question is, is the training we are delivering reflecting in the actions taken while on the emergency scene. The answer is yes, the FF are preforming tasks they had not performed before our training started.

Upon arrival on scene the officers and FF are taking command, reporting doing size ups, performing 360's and running the calls and IC. Is it perfect, no but it has been a big improvement from the past.

At MVC's EMT's and FF alike approach the incident scene with the proper tools and PPE's, doing 360's stabilizing the car and preforming patient assessment. Pulling hand lines to protect the occupant (s) and FF. Working as a team and not freelancing like they use to do.

The volunteers have become very familiar with using the SCBA's then they ever were. We have quarterly SCBA training and all the volunteer are required to participate.

These are just a few improvements we have made over the past 7 years. The list goes on.

The question should be asked of the FF, "Do they feel the training has improved their capabilities and confidence when mitigating the dynamics that takes place during of an emergency event.
